1. Permits, Change, Transfer, Renewal, Sale

The permit for this reclaimed site was renewed effective August 28, 2004 and expires August 30, 2008.

2. Signs and Markers

Signs with the required information were posted at the access to the reclaimed site. The fence at the entrance to the reclaimed area has been repaired. The fence along the base of the reclaimed fan portal has been removed as it is no longer needed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main cell of the sediment pond contained water from recent storms. The ponds were inspected on 8/18/05 showing no signs of instability or erosion.

4.c Hydrologic Balance: Other Sediment Control Measures

Surface roughening implemented during reclamation has provided adequate sediment control for the site.

4.d Hydrologic Balance: Water Monitoring

Hard copies of the 1st and second quarter water monitoring data were available for inspection. The second quarter data was uploaded into the data base on 9/28/05. There were no anomalies or parameter exceedances.

4.e Hydrologic Balance: Effluent Limitations

DMR"s were current through August of 2005 reflecting no discharge from the three-celled sediment pond.

13. Revegetation

Thistle noted during the previous inspection had been sprayed and or removed from the site. The thistle was primarily located in the second cell of the sediment pond and along the main drainage.

21. Bonding and Insurance

Liberty Mutual Insurance Company holds the \$641,443.00 bond. St. Paul Fire & Marine Insurance Company carries a \$500,000 general liability coverage that expires July 31, 2006.
