1. Permits, Change, Transfer, Renewal, Sale

The permit for the Gordon Creek property was renewed effective August 8th, 2004. Correspondence regarding the midterm review was initiated March 5, 2007 to Chris Hansen, resident agent for the property. The seven items outlined in the document were discussed with Dan Guy, Dave Darby, Priscilla Burton and myself during the site visit. Memos from Priscilla Burton and Wayne Western were provided to Dan on site. Reclamation of the three celled sediment pond was completed in accordance with the reclamation procedures outlined in the approved MRP.

12. Backfilling And Grading

The three celled pond was removed and the area was recontoured and graded to the AOC of the surrounding and adjacent topography. Additional surface roughening was implemented to improve moisture retention and sediment control.

13. Revegetation

The reclaimed area was hydroseeded with mulch and the approved seed mix.
