

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Jacob's Pond was observed as dry. The spillway appears stable, as do the impounding slopes.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaimed site has abundant vegetation. There is no visible evidence of erosion at the site.

4.d Hydrologic Balance: Water Monitoring

The Permittee notified the Division on June 28, 2010 that the first quarter of 2010 water monitoring information had been successfully uploaded into the DOGM electronic data base pipeline for the Gordon Creek 2 / 7 / 8 permit area. Mr. Chris Hansen noted that only one monitoring point was accessible (2-2-W) due to snow depths. Heavy runoff was occurring, having a possible influence on the TDS and metals concentrations for the sample taken at 2-2-W. As observed this day, there was no flow in Bryner Creek.
