4.a Hydrologic Balance: Diversions

Bryner Creek had recently had flow, as did the first reclamation diversion reporting to it.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Pocked areas of the sediment pond reclamation area contained water from the overnight event.

The County has received numerous thunderstorm events over the past few weeks. The vegetation on the reclaimed areas looks very good at this time.

21. Bonding and Insurance

The general liability insurance coverage for this site will expire on July 31, 2011.

22. Other

The surface landowner has requested that Mountain Coal Company install a gate and a rock fence line somewhere on the access road to prevent unauthorized access into the reclamation area. Ms. Vickie Miller (Canyon Fuel Company, LLC / Dugout Canyon Mine) met with this Division representative on this day to discuss the gate / rock fence location. The location being proposed is below the permit area but still on Jacob's property. Ms. Miller intends to meet with Mr. Rex Sacco of Carbon County to discuss which location would best suit all of the parties concerned.
