**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Jacob's Pond was observed as full, but not overflowing. Its water volume was very turbid. Flow from the seeps above the pond was minimal.

Bryner Creek contained no flow; all reclamation diversions were dry.

No wildlife was observed during today's inspection.

**12. Backfilling And Grading**

All backfilled areas are stable.

**16.a Roads: Construction, Maintenance, Surfacing**

Canyon Fuel Company will install a new gate at the east permit boundary for the landowner, Mr. Cal Jacobs and family. It is understood that Carbon County will relinquish the short length of road (approximately 300 feet) from the lowest fence boundary up to what is marked the "End of County Road". The new gate location will be on Jacob's land.
