1. Permits, Change, Transfer, Renewal, Sale

There are no MRP amendments pending.

3. Topsoil

There are no remaining topsoil storage piles. Topsoil was utilized during the reclamation process.

4.a Hydrologic Balance: Diversions

The constructed ditch through Bryner Canyon was dry with no apparent erosion.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Jacob's Pond was inspected on March 28, 2012. The water in Jacob's pond is about 2 feet below the spillway elevation.

4.d Hydrologic Balance: Water Monitoring

The only visible water flowing on site was a very small amount of flow from a seep above Jacob's Pond. 2012 1st quarter water monitoring data has been reported to the OGM database.

8. Noncoal Waste

No waste was observed on site.

9. Protection of Fish, Wildlife and Related Environmental Issues

Numerous birds and ground squirrels were observed during the inspection.

21. Bonding and Insurance

General liability insurance is renewed annually and in effect through July 31, 2012. A bond amount of \$641,443.00.
