Jacob's pond appeared stable, without any problems noted in the embankments or outlet. The pond was inspected and stamped by a PE in 3rd quarter 2013.

Water monitoring has taken place and been submitted to the DOGM database as required in the permit.

21. Bonding and Insurance

The facility is bonded for an amount of \$641,443 and is insured through February 1, 2015.
