**2. Signs and Markers**

The identification sign by the main gate has the required information and meets the R645 coal Rule requirements.

**3. Topsoil**

The topsoil had slight disturbance from equipment for the repair of the diversions. The permittee did rip and reseed these areas where compaction occurred. The new pocking is much better than the original pocking.

**4.a Hydrologic Balance: Diversions**

Several diversions, the permittee repair from last year's rainstorms.. All diversions would function as design meeting the R645 Coal rules standards for water flow in diversions. See pictures of the repair work. The permittee added rip rap and re-graded segments of the existing diversions.

**8. Noncoal Waste**

I did not notice any non-coal waste during the inspection.

**13. Revegetation**

I informed the permittee about the abundant amount of thistle on the property. The permittee already contacted a company to remove/spay the thistle. The next inspection the problem should no longer exist. The tire marks that compacted the ground in several areas were rip and re-seeded.
