All topsoil was use in reclamation.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked, and, had functioned as designed, during a recent storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The Jacob's Pond was inspected was inspected for the second quarter of 2015.. The inspection report is P.E. certified. No hazardous conditions were reported. The report states the pond is stable and contains some water. The sediment pond was not discharging during the inspection. I did not see any hazardous conditions during the inspection.

8. Noncoal Waste

No non-coal waste was observed during the inspection.

10. Slides and Other Damage

No slides or other damage were noticed during the inspection.

12. Backfilling And Grading

The reclamation site is completely backfilled and graded.

13. Revegetation

Thistle has been removed. There was abundance of thistle growing near the cattle pond. A weed control expert was contracted to remove the thistle.

19. AVS Check

AVS checks are made at the Division's main office in Salt Lake City.

21. Bonding and Insurance

The bond amount is currently \$171,000. The insurance policy will expire on February 1, 2016. The policy number is GL6576428.
