1. Permits, Change, Transfer, Renewal, Sale

There are no new permitting actions with the Division.

2. Signs and Markers

I inspected the identification sign and it complies with the Requirements of the R645 Coal Rules.

3. Topsoil

The topsoil was covered with 10 to 15 inches of snow. The topsoil is protected by pock marks. This keeps soil within the reclaim area.

4.a Hydrologic Balance: Diversions

The diversions were covered with snow. It was noticed walking the main diversion leaving the reclaim site that water was flowing. The south facing mountain is bare of snow. The melting water had to go through these diversions. Therefore, it can be concluded that the diversions are functioning as design.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The cattle pond contained water and was frozen over. No water was observed discharging from the pond.

8. Noncoal Waste

No non-coal waste material was noticed.

10. Slides and Other Damage

No slides or other damage were noticed during the inspection. Cut-slopes appeared to be stable.
