I made two attempts to inspect Gordon Creek on February 1st and 28th. Both times the county road was snow covered and I was unable to get to the mine site.

The site has been reclaimed in excess of 10 years. The permittee will most likely apply for Phase III bond release this year. They may receive full or partial release depending on decisions the Division will make over last year's disturbance by equipment to reconstruct three diversions. Diversions #1, #2, and the main diversion were reconstructed last year.
