2. Signs and Markers

I inspected the identification sign and it meets the requirements of the R645 Coal Rules. The sign has all the required information. See Photo

3. Topsoil

All topsoil was used in reclamation of the mine site.

4.a Hydrologic Balance: Diversions

Diversions were open and functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The cattle water pond was inspected for the second quarter. No hazardous conditions were reported.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaim area is pocked to treat water and help with vegetation.

4.d Hydrologic Balance: Water Monitoring

Water monitoring information is taken by the permittee and is sent electronically to the Division in Salt Lake City. This information is reviewed and analyzed by the Division staff. A report is written.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection. The reclaim site appears to be stable.

12. Backfilling And Grading

The reclamation site is completely backfilled and graded.

13. Revegetation

Vegetation is starting to grow in the road/path used for repairing the diversions a couple of years ago.
