

1. Permits, Change, Transfer, Renewal, Sale

3. Topsoil

All topsoil was used in reclamation of the mine site.

4.a Hydrologic Balance: Diversions

The diversions were open and would function as designed. See photos.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The cattle watering pond was inspected by the permittee. It was reported that the pond was stable with no hazardous conditions.

4.d Hydrologic Balance: Water Monitoring

Water monitoring information is taken by the permittee and is sent electronically to the Division in Salt Lake City. This information is reviewed and analyzed by the Division staff. A report is written.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

10. Slides and Other Damage

No slides or other damage was noted during the inspection.

12. Backfilling And Grading

The reclamation site is completely backfilled and graded.

13. Revegetation

The access area used to fix diversions has vegetation growing into the pocks. It appears mostly to be grasses. See Photos
