Dear Mr. Wells:

On December 29, 1978, you submitted a Notice of Intent to Commence Exploratory Drilling in Grand and Carbon Counties of Utah for the Intercoast Coal Company of Sacramento, California. In my reply of January 19, 1979, a commitment to plug the drill holes as specified in Rule M-3(5)(c) and a commitment to reclaim the disturbed area as specified in Rule M-3(5)(d) was requested. As of this date these items have not been received.

The Division requests that you inform us as to the present status of the operation. At this time I would like to point out that it is illegal to conduct exploratory drilling without first filing an acceptable Notice of Intent. The Notice filed on December 29, 1978, must be amended to include plugging and reclamation.
