1. Permits, Change, Transfer, Renewal, Sale

On October 20, 1995, the Division wrote Soldier Creek and terminated the mid-term review. The letter reminded Soldier Creek of commitments to revise the PHC and to obtain final approval for all proposed facilities by September 15, 1996.

On October 19, 1995, the Division forwarded a draft technical analysis of the Alkali Lease Incidental Boundary Change to Soldier Creek. On November 7, 1995, the Division issued a revised permit including this incidental boundary change. The permit was issued conditional on receiving approval of the Assistant Secretary of the Interior prior to mining the area.


The Division received revised ownership and control information dated October 30, 1995.
