1. PERMIT -

The operator during the inspection updated his drainage and alternate sediment control to reflect what is on the ground. The original map was field changed by the inspector during the period of exploration. The new map will be submitted to the Division and be implemented into the plan.

4a. DIVERSIONS -

There is only one small diversion which enters the creek. This ditch was performing as designed.

4c. OTHER SEDIMENT CONTROL MEASURES -

The exploration site uses exclusively alternate sediment control since there are small areas of disturbances. The site sediment control consists of silt fences, berms and straw bales. The ASCA were inspected and were performing as designed.
