1. Permits, Change, Transfer, Renewal, Sale

On March 13, 1995, the Division received a response to the mid-term review. This response is being reviewed.

4. Hydrologic Balance

a. Diversions

Some ditches and culverts need to be cleaned. In particular, the cobblestone ditch east of the office has a moderate amount of sediment in it.

9. Protection of Fish, Wildlife, and Related Environmental Values

I spent about three hours in Dugout Canyon with Sharon Adair watching for golden eagles. As discussed in the February inspection report, Soldier Creek plans to do some exploration in this area this spring. A pair of eagles has been frequenting the area, but the nest location is unknown. We saw two eagles flying in the area for a few minutes at about 11:00 A.M., and we had a few other glimpses. There was nothing indicating where the nest might be.

18. Support Facilities/Utility Installations

The fuel tanks are in concrete retaining structures. The structures have drains, but the cap was missing from one of them. If there was a spill, fuel would not stay in the structure but would flow to the sediment pond. This cap needs to be on the drain pipe except when the area is being cleaned.

21. Bonding and Insurance


The insurance policy was renewed March 16, 1995. The company affording coverage is the Reliance National Indemnity Company, and the policy number is NGA0121020-00. It expires March 16, 1996. Coverage is \$2,000,000 for each occurrence and \$2,000,000 aggregate. The policy includes the cancellation clause required by the Division.

The Division holds surety bond number U1712871 with United Pacific Insurance Co. in the amount of \$3,238,000. The reclamation agreement says the disturbed area is 24 acres and the permit area is 5238 acres. The plan says the permit area is 4909.69 acres. Adding acreage figures shown in the plan for various leases, I calculated the permit area to be about 4946 acres. The disturbed area acreage figures appear to be correct.
