

Please find enclosed herewith three copies of the above-referenced Application for Permit Transfer. On behalf of the applicant, Canyon Fuel Company, LLC, I am submitting this application pursuant to Utah Admin. R645-303-300. Please note the following:

1. R645-303-321.100: The name of the current permittee is Soldier Creek Coal Company, P.O. Box I, Price, Utah 84501. Soldier Creek Coal Company is a wholly owned subsidiary of Sage Point Coal Company which, in turn, is a wholly owned subsidiary of Coastal States Energy Company. The Coastal Corporation is the parent corporation for Coastal States Energy Company.

2. R645-303-321.300: Under a Purchase and Sale Agreement entered into by The Coastal Corporation, Coastal Coal Company, Inc., Atlantic Richfield Company, and Itochu Corporation, Coastal States Energy Company and all its subsidiaries will be merged into a newly formed limited liability company, Canyon Fuel Company, LLC. Canyon Fuel Company, LLC will then be purchased by Arco Uinta Coal Company, a wholly owned subsidiary of Atlantic Richfield Company, and Itochu Coal International, Inc., which will be a wholly owned subsidiary of Itochu Corporation. Itochu Corporation is presently in the process of forming Itochu Coal International.

3. The enclosed application seeks approval to change the permittee's name to Canyon Fuel Company, LLC and updates Chapter 1, Legal, Financial, Compliance, and Related Information, of the existing permit to reflect the anticipated transaction. Please

note that the current Chapter 1 information will remain in effect until the merger and sales transaction closes, whereupon the information recited in the enclosed permit transfer application will become effective.

The combination of the thirty-day public comment period and the December 20, 1996 deadline for closing have forced us to submit this application with some information omitted. These omissions include (1) several social security numbers for officers and directors,<sup>1</sup> (2) the employer identification number for Itochu Coal International, Inc., and (3) the certificate of insurance required under R645-301-117.100. Moreover, we still must provide the replacement surety bond and proof of publication of the public notice required under Utah Admin. R645-303-322. We plan to supplement the application to supply these items on or before the closing date.

The parties to the transaction anticipate closing on December 20, 1996 contingent upon approval of this permit transfer. We request that this transfer be effective as of that anticipated closing date, assuming that we have satisfied all information requirements.

Should your review of this submittal identify the need for additional information or clarification, please do not hesitate to contact me. We appreciate the assistance and cooperation that Daron Haddock, Mary Ann Wright, and Pamela Grubaugh-Littig of your staff have already provided in the preparation of this submittal and look forward to working with them to complete this transfer.
