NOTE: Although temperatures have been in the mid-forties the last couple of days, much of the site remains under snow. Upper Soldier Creek is frozen and snow covered.


4b. HYDROLOGIC BALANCE: SEDIMENT PONDS AND IMPOUNDMENTS

The surface of the mine site sediment pond is frozen and is well below (approximately five feet) the primary spillway discharge elevation. The pond was receiving a very small inflow this day. The inslopes of the pond are snow covered.
