Diversions are snow covered. Melting of snow was occurring.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond had snow but no real water. The sediment pond was inspected for the fourth quarter. No hazardous conditions were reported.

4.d Hydrologic Balance: Water Monitoring

Water monitoring has been submitted to the Division for the fourth quarter.

4.e Hydrologic Balance: Effluent Limitations

Sediment pond did not discharge for the fourth quarter.

8. Noncoal Waste

The mine site is snow covered. There is still old equipment on the property.

15. Cessation of Operations

There is no activity at the mine site.

16.b Roads: Drainage Controls

Roads are snow covered.

18. Support Facilities, Utility Installations

No new facilities constructed since the last inspection.

The Air Quality permit is DAQE-334-94. The SPCC Plan was reviewed on Dec 3, 2004

21. Bonding and Insurance
