The Utah Division of Oil, Gas and Mining (Division) has completed a review of the revised Mining and Reclamation Plan (MRP) for the Centennial Project. The Division has determined the plan to be apparently complete. In compliance with Section UMC 786.11 (b) and (c) of the Utah Coal Mining Reclamation Act (UMC Section 40-10-1 et seq), notice is hereby given to all appropriate agencies having a jurisdiction over or an interest in the area of the operations that a complete plan is available for public review.

Andalex Resources, Inc. (ARI) is proposing to add three (3) federal lease modifications, one new federal lease and one new fee lease to the currently permitted Centennial Project. Underground lease additions total 996 acres. The new leases will be mined as an extension of the existing Pinnacle Mine. The lease modifications will be mined as part of the Aberdeen Mine, which will be developed in the near future.

The permit area is located on the Deadman Canyon U.S.G.S. 7.5 minute quadrangle map. The existing surface facilities at the Centennial Project are located in Deadman Canyon, approximately ten miles northeast of Price, Utah.
