4a. DIVERSIONS -

Diversions throughout the property were spot-checked for compliance. The ditches were functioning as designed. There were some rocks in the ditches from freezing and thawing conditions. They will be removed by the operator.

4b. SEDIMENT PONDS -

The sediment ponds were not discharging at the time of the inspection. They contain some snow melt water but the major portion of the pond bottoms are snow-covered; signs of erosion were not detectable.
