Andalex has submitted an amendment for ASCA's to update the MRP. The amendment was reviewed at the Price Field Office. It now has been sent to the Division in SLC for final review.

**4. DIVERSIONS - SEDIMENT PONDS**

The diversions were spot checked for compliance. The ditches were functioning as designed with no problems noted.

The sediment ponds were not discharging during the inspection. The embankments, inlets and outlets were covered with snow, therefore, its was impossible to inspect for erosion.


