4A. DIVERSIONS -

The diversions were spot-checked and complied with the Mining and Reclamation Plan and the R645 Coal Rules. Several of the ditches had recently been cleaned out.

4B. SEDIMENT PONDS -

The sediment ponds were spot-checked with no hazardous conditions being noticed.

The sediment ponds contained little or no water.

There were no signs of erosion of inlet, outlets, and embankments.

7. REFUSE -

There is a small amount of refuse that needs to be shipped from Andalex to Wildcat Loadout for permanent storage.
