1. PERMIT -

The permittee will be submitting a major amendment for adding a lease to the existing permit area.

3. TOPSOIL -

The vegetation has started to turn green on the topsoil piles. No signs of wind or water erosion.

4a. DIVERSIONS -

The diversions were spot-checked and some maintenance is needed. The permittee will regrade the diversion. There are no violations at the present time.

4b. SEDIMENT PONDS -

The sediment ponds did contain a small amount of water but will not likely discharge in the near future.

The sediment ponds were inspected and no hazardous conditions were noticed.
