Dear Ms. Littig:

Enclosed are 5 copies of amended pages and maps requesting approval of a Boundary Change for the Centennial Project Permit Area.

The proposed change is in the remaining Mathis Tract (380.00 acres) State L.B.A. (80.00 acres), and in the remaining Federal Summit Creek Lease Area (630.21 acres), as described on the amended pages and Plates. It amounts to a total change of 1090.21 acres.

The proposed change is for underground mining only. Due to the deep cover (from 2,600' to 3,100'), the change will have no effect on soils, vegetation, wildlife, land use, air quality, engineering, geology, surface hydrology or bonding. A PHC has also been prepared and previously submitted, indicating no expected adverse affects to the hydrologic regime. Also, the Division's CHIA document for this proposed permit change has been completed.
