2. Signs and Markers

The mine permit ID sign located at the contact point of the public access to the permit area contained the required information. Other signs and markers observed during the inspection met the coal rules.

4.c Hydrologic Balance: Other Sediment Control Measures

Three to four silt fence structures located along the access road to the fan need maintenance. The structures are located more toward the upper portion of the access road near the fan. Mike Glasson noted the structures so that they can be cleaned.

4.d Hydrologic Balance: Water Monitoring

First quarter 2006 water monitoring is in the EDI website and is uploaded. Water monitoring is current.

8. Noncoal Waste

A few noncoal items were observed at that the mine site that were not contained within the approved noncoal storage area. Mike Glasson made note of the items, so that surface personnel can pick them up.
