8. Noncoal Waste

Numerous items identified during the May 2008 inspection were still present around the oil storage area. No effort had been taken to pick up the shrink wrap and boxes that have been wind blown into the tree area above the oil storage area. Noncoal waste items have been a problem in the past and continue to be a problem in the present. Enforcement action was taken by issuing Citation 10024. Citation 10024 was issued for failure to control an/or contain noncoal waste items in the approved and designated control structures.

16.a Roads: Construction, Maintenance, Surfacing

Several silt fences along the reaches of the access road to the remote fan area are in need of maintenance and repair. Dave Shaver indicated that he would like to replace the silt fences with waddles in an effort to reduce the deterioration and maintenance frequency. This would be an acceptable alternative.

These structures need to be addressed to avoid future problems and compliance action.
