1. Permits, Change, Transfer, Renewal, Sale

The only permit condition currently in place is that the permittee must submit all water monitoring data in an electronic format to the Division's web site. This condition is being met.

2. Signs and Markers

The mine permit ID signs are located at the contact points of public access to the permit area.

4.a Hydrologic Balance: Diversions

Citation 10032 was terminated during the inspection, because the large rocks had been pulled back out of the disturbed diversion DD-3. The diversion can now function as designed and approved in the mining and reclamation plan (MRP). The abatement deadline was listed as 02/04/2009. Dave Shaver notified the Price Field Office by voice mail on 02/03/2009 that the rocks had been removed from the diversion.

8. Noncoal Waste

The majority of the noncoal waste items were picked up and disposed of properly. Small amounts of noncoal waste items are still present on the slope above the fuel storage facility.

22. Other

The two large signs located at the gates that restricted access have been removed.
