2. Signs and Markers

The mine permit ID signs are located at the contact points of public access to the permit area.

4.a Hydrologic Balance: Diversions

There is brattice in disturbed diversions DD-11 and DD-2. DD-11 is located immediately below the rock dust tank area. DD-2 is in the same area as DD-11 but is adjacent to the main road.

The culvert outlet by the main bathhouse is partially collapsed and needs to be fixed to meet the designs in the mining and reclamation plan (MRP).

The undisturbed culvert inlet by the main bathhouse area is covered by dried weeds and during a storm event will cause the inlet to plug. The weeds need to be removed so the inlet can function properly.

5. Explosives

The powder magazine has been removed from the site. The cap magazine is still in place.

8. Noncoal Waste

Noncoal waste items were observed through out the site. Major items of concern are: Plastic sheeting east of the main office, Garbage by the main bathhouse, Garbage in the diversion by the fuel storage area, Counter top outside of the lamp house, Garbage can in the abandoned sediment pond.

22. Other

Dried weeds are accumulated around the fuel storage area. These items are a combustible source and need to be removed immediately.
