2. Signs and Markers

The mine identification sign is in place at the point of public access to the permit area. The sign contains the required information.

4.a Hydrologic Balance: Diversions

Metal strips were found bridging the diversion by the bathhouse. The obstruction was removed during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The 2009 annual pond certification report shows:

Sediment Basin B, sediment clean elevation @ 7081.0 and existing sediment level @ 7079.6.

Sediment Pond C, sediment clean elevation @ 7046.9 and existing sediment level @ 7042.7.

Sediment Pond E, sediment clean elevation @ 6946.5 and existing sediment level @ 6946.2.

Sediment Pond E is only three tenths of an inch (.3) away from requiring the pond to be cleaned and may be to the clean level now, since the certification was done on December 10, 2009. Additional sediment from the snowmelt may have raised the sediment level. The pond should be cleaned spring or summer of 2010.
