

2. Signs and Markers

Mine identification sign is in place at the point of public access to the permit area. Sign contained the required information.

18. Support Facilities, Utility Installations

Eight to ten inch piping hole was observed in the pad by the main office. The hole is at the entrance to the main pad on the right side as a person enters. The placement of the hole is adjacent to a large sandstone rock. The hole can create an instability in the pad if not repaired.

22. Other

The four fifty five gallon drums observed on a pallet in the storage yard have been moved to a location to the side of the shop. The drums are bound together by a metal band. All four drums are full. Drums need to be placed in a containment in case they leak or are ruptured.
