2. Signs and Markers

The mine identification sign is in place at the point of public access into the permit area.

4.a Hydrologic Balance: Diversions

Culvert inlet adjacent to the most recent Truck Load out that traverses the county road is 100% blocked. It appears that the hillside has sloughed and covered the inlet. Probably from the moisture incurred from winter conditions. The inlet needs to be opened immediately.

The culvert outlet coming off the pad area where the rock dust tank was located is about 50% plugged. This outlet is on the northeast side of the main bath house. The outlet and the diversion leading away from the outlet needs to be cleaned.

8. Noncoal Waste

Noncoal waste (shrink wrap) is on the ground and in the trees at the upper most topsoil pile. This pile is located in a draw right before the storage area that leads to the explosive storage area. The material needs to be gathered and placed in the approved noncoal waste storage area.
