2. Signs and Markers

The mine identification sign is located on the off side of the road as you enter the mine site from the county road. The sign is placed at the entrance into the permit area. The sign contains all of the information required by regulation.

3. Topsoil

The topsoil piles are snow covered. The topsoil signs are visible on top of the topsoil piles.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds are dry with the exception of the snow covering from recent storms.
