**2. Signs and Markers**

The mine identification identified on the prior inspection that was down has been re-secured and was in place at the entrance into the permit area. The sign contains the required information.

Topsoil sign for the topsoil pile that which is located on the embankment of the de-commissioned sediment pond is down. The sign needs to be placed back on the topsoil pile.

**4.a Hydrologic Balance: Diversions**

The culvert inlet for undisturbed drainage that is located adjacent to the oil storage area has been cleaned. This item was identified on the prior inspection.

The tree in the road ditch by the upper most part of the mine site looking up-canyon has been removed from the diversion.

The road culvert inlet by the shop is half plugged and needs to be cleaned.
