2. Signs and Markers

The mine identification sign is located at the entrance into the mine site and permit area. The sign is of a substantial size, legible and contains all of the information that is required by the regulations.

5. Explosives

Explosives are not presently stored on site. One storage magazine has been removed.

22. Other

During the inspection several stands of thistle were observed within the mine site. Thistle was observed in the sediment cells below the bath house pad, along the access road just above the shop entrance, on the pad area located just above the shop pad. The thistle on the pad just above the shop pad is where the thistle is showing the most dominance. The thistle is segregated into two colonies. One at the lower edge of the pad near the slope toward the shop pad and another about mid pad. The thistle needs to be removed and measures need to be taken to eradicate future growth.
