**2. Signs and Markers**

The identification sign contain the necessary information as required in the R645 Coal Rules.

**3. Topsoil**

Several of the de-gas wells are graded, using the available topsoil, and seeded. The sites have a fence around them to keep cattle from grazing. Some of the sites still need to remove stand pipes (vertical culvert) before Phase I and II bond release can be given. Permittee plans on having these removed this year.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The sediment ponds at the mine site were inspected. I did not see any hazardous conditions. These sediment ponds were dry.

**4.c Hydrologic Balance: Other Sediment Control Measures**

I did not see any sediment control measures at the de-gas sites. The area is not pocked or silt fence, straw bales used. However, I did not see any sediment leaving the site. These site were inspected by the Salt Lake staff last year.

**9. Protection of Fish, Wildlife and Related Environmental Issues**

There were elk, deer and a sage grouse near the de-gas wells.

**12. Backfilling And Grading**

Once the stand pipes have been removed these sites will meet AOC.

**16.a Roads: Construction, Maintenance, Surfacing**

Some of the roads to the De-gas wells will be reclaim.
