2. Signs and Markers

The identification sign contain the necessary information as required in the R645 Coal Rules.

3. Topsoil

The topsoil soil piles had good vegetative cover. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

I inspected the diversions throughout the property. Culverts and diversions were open. No water was flowing within the diversions during the inspection. The permittee had clean several diversions in the past few months.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds. They contain a small amount of water. It is unlikely that these sediment ponds will discharge in the near future. No hazardous conditions were noticed. The inside and outside of the embankments were stable.

8. Noncoal Waste

The site was clear of non-coal waste materials. There are storage areas of old mining equipment. In my opinion much of the material could be sold for scrap metal.

10. Slides and Other Damage

No slides or other damage was notice during the inspection.
