1. Permits, Change, Transfer, Renewal, Sale

There are no amendments or permitting action with the Division at the present time.

2. Signs and Markers

The identification sign is at the main gate to the property. The sign meets the requirements of the R645 Coal Rules.

3. Topsoil

The topsoil piles are stable and vegetative. There are no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

I inspected the diversion and culverts during the inspection. The culverts and diversions were open and would function during a storm event. There was no excessive erosion within the diversions. No water was flowing within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were mostly dry. No water was entering the ponds. The sediment ponds appear to be stable with no hazardous conditions notice. The embankments, inlets and outlets were stable.

8. Noncoal Waste

The site was clear of oil cans, paper, and bottles. However there is a large amount of used and old mining equipment. This property is a storage center for equipment of all types.

16.a Roads: Construction, Maintenance, Surfacing

Roads are in good condition. Road drainages are open and would function during a storm event.
