1. Permits, Change, Transfer, Renewal, Sale

There is one permit action by the permittee to the Division. It is Centennial Temporary Cessation, due September 16th.

2. Signs and Markers

I checked the identification sign at the main gate and it complies with the requirements of the R645 Coal Rules. See Picture

3. Topsoil

Topsoil piles were stable with no signs of water or wind erosion. See Pictures

4.a Hydrologic Balance: Diversions

The mine site had a major rainstorm this weekend. The majority of the diversions and culverts were open and performed well during the storm event. However, there were a couple of diversions and culverts which got half full of sediment. The permittee was in the process of cleaning these structures. No NOV was issued since the permittee was cleaning these structures prior and during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds contain a small amount of water. There was no hazardous conditions noticed during the inspection. The embankments appear to be stable. See Pictures. It is unlikely these sediment ponds will discharge in the near future.

8. Noncoal Waste

The site was generally clear of non-coal waste materials. There is plenty of old mining equipment on this site.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

15. Cessation of Operations

The permittee has sent in a notice requesting temporary cessation. The action is scheduled to be reviewed by the Division by September 16th.

16.b Roads: Drainage Controls

Some work is scheduled for road diversions for cleaning out of sediment material.

18. Support Facilities, Utility Installations

The shop building is operating, repairing mining equipment.
