2. Signs and Markers

I checked the identification sign at the main gate and it complies with the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles at Andalex. These piles were stable and no signs of erosion. They are well vegetated.

4.a Hydrologic Balance: Diversions

The diversions and culverts were recently cleaned from a major rainstorm. It was reported in the Price City newspaper that the storm was a 1,000 year storm event. See photos

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds did contain water but were not discharging during the inspection. It is unlikely that these sediment ponds will discharge in the near future. The embankments appear to be stable. See Photos

8. Noncoal Waste

The mine site has a large amount of mining equipment. Some appears to be usable and others are questionable in my opinion.

10. Slides and Other Damage

I did not see any slides or other damage on or to the mining property.

16.a Roads: Construction, Maintenance, Surfacing

Roads drainage controls were open and functioning as designed.

No new additions of support facilities since the last inspection.
