2. Signs and Markers

The identification signs at the waste rock and main mine facilities were checked. Both of these signs have the new address and phone number of the operator posted. The signs are in compliance.

3. Topsoil

The temporary topsoil pile located on top of the waste rock site has a weakened berm that needs to be strengthened.

4.a Hydrologic Balance: Diversions

Road diversions at the mine site leading into the main sediment pond were open and functional according to design.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The mine main sediment pond contains water and is frozen over. The two sediment ponds located at the waste rock site were dry. All ponds appeared stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was actively receiving material and being leveled and graded. Pile appeared stable.
