Dear Mr. Jones:

This has reference to your blasting permit amendment. The record will show the following:

- You submitted an amendment application which is currently pending.
- You were notified there were two deficiencies that needed to be corrected before the amendment could be approved by officials at the Salt Lake DOGM office.
- The deficiencies concern two items:
 - (1) The MRP text contain language on the storage of explosives.
 - (2) The surface facilities map show where the cap and powder magazines will be store within the disturbed permitted area (DOGM Permit).

We need to call to your attention two items: (a) you have no authorization to store explosives on the mine site and (b) you will be in violation of the Utah Coal Rules should you store explosives on the mine site before receiving an approved amendment. Please submit the earmarked documents (1) and (2) above to Joe Helfrich, Division Oil, Gas, and Mining, 1594 West North Temple, Suite 1210, Box 145801, Salt Lake City, Utah 84114-5801, by March 1, 1999.

Failure to submit the required information by March 1, 1999 will result in disapproval of your blasting application without further notice.
