1. Permits, Change, Transfer, Renewal, Sale

The permittee is currently permitted to mine a portion of federal lease # U 74804. A meeting is scheduled for October 9, 2003 with DOGM representatives to discuss the permitting requirements for the remaining portion of the lease. The previous permitting action on this lease required the addition of a monitoring well with two years of base line data. This has been completed.

2. Signs and Markers

Signs containing the requisite information were posted at access points to the property.

3. Topsoil

The lower topsoil pile at the entrance to the property was inspected. There is a berm along the south east side of the pile. The remaining sides are surrounded with straw bales. According to chapter 3, section 3.5.2 berms or straw bales were to be placed around the stockpile. The consensus was to construct a berm around the remaining portion of the stockpile and allow the bales to remain in place.
