
To Whom It May Concern:

This constitutes notice to all concerned that the proposed transfer of Permit Number C/007/020 to Hidden Splendor is subject to the claims of Blue Blaze Coal Company and William Roger Skaggs and Margaret Skaggs. The Skaggs address is PO BOX 784, PRICE, UT 84501.

The Skaggs base their claim upon their assignment of an application for a permit to mine coal for the Blue Blaze Mine in Carbon County, Utah covering a large portion of the lands described in the notice published by the division on April 8, 2003. The original mine permit application was designated PRO/007/020. That application was assigned by the Skaggs and Blue Blaze on March 28 to Horizon Coal Corporation. Horizon Coal Corporation in turn has assigned the application/active permit to other parties. The Skaggs and Blue Blaze Coal have continuously asserted their claim to the right to receive consideration for their assignment and transfer. This letter is a continuation of providing notice of their interests.

The Skaggs and Blue Blaze do not seek to block the transfer as noticed by the publication on April 8, 2003 but once again affirmably assert their claim to consideration that is to be paid from coal mine pursuant to the permit.
