1. Permits, Change, Transfer, Renewal, Sale

The permittee is actively gathering information to extend the permit area. When the permit change is approved, it will grant the permittee the ability to mine additional federal coal. The amendment would require federal approval.

3. Topsoil

The topsoil piles are covered with snow. No signs of wind or water erosion were noticed.

4.a Hydrologic Balance: Diversions

The diversion next to the road to the bathhouse needed to be cleaned out. The diversion had sediment and snow within the diversion. The permittee was actively working on the diversion once it was identified.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond did contain a small amount of water and was not going to discharge in the near future. No hazardous conditions were noticed during the inspection of the sediment pond.

7. Coal Mine Waste, Refuse Piles, Impoundments

Permittee has no approval for a refuse pile. No coal mine waste was on the surface.

8. Noncoal Waste

The disturbed area was clear of non-coal waste material.

16.b Roads: Drainage Controls

The permittee was actively working on the road drainage once it was identified.
