Hidden Splendor Resources respectfully submits the response to the Technical Analysis of the above referenced Task ID as requested by the March 9, 2005 Technical Analysis.

Following a conference call on March 18, 2005 with Jim Smith and Wayne Western of your office and Alex Walker, Mark Wayment and myself of Hidden Splendor Resources, Inc., the requested items were discussed and the appropriate changes were made.

Additionally, several of the items discussed were requested by Hidden Splendor Resources, Inc. personnel to be approved as stipulations or conditional approvals.

Specifically, R645-301-525-290, Item #2 requesting a stream profile for Beaver Creek has been agreed to however, we will be unable to complete this request until such time as snow cover has melted and the area is accessible. Also, R645-301-525.490, requesting subsidence monitoring stations be placed along Beaver Creek and seeps and springs in the area cannot be accomplished for the same reason. Changes to the text were made addressing this item and the proposed subsidence monitoring stations are shown on the amended Plate 3-3.

These stipulations were agreed to by both entities during the March 18, 2005 conversation.

Along with this submittal are five (5) CD's containing the updated files and drawings.


