2. Signs and Markers

The mine identification sign is located adjacent to the public road leading to the mine site. The sign is located as such that it is at the point of public access to the permit area. Information found on the sign is in compliance with the regulations.

Topsoil signs are down on ground at topsoil pile below the sediment pond. Signs are still on site. Signs need to be re-installed to be visible.

4.a Hydrologic Balance: Diversions

Care needs to be taken to keep diversions open and make sure that diversions are not blocked and/or obstructed by vehicular parking.

8. Noncoal Waste

Observed two dumpsters full of noncoal waste. In addition there is noncoal waste stacked against the dumpsters with enough volume to fill an additional 1 1/2 dumpsters. The material needs to be hauled off site and properly disposed of in approved landfill.
