2. Signs and Markers

The mine identification is located at the point of public access into the permit are. The sign contains the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Material from snow removal activities is placed at the border to the sediment pond. Some material has sloughed off toward the pond. Care needs to be taken to prevent material from entering the pond.

8. Noncoal Waste

Items of noncoal waste were observed on the ground where the noncoal disposal units are kept. The material has probably become liberated during the bin removal process. Noncoal waste needs to be picked up and place in the storage bin.

18. Support Facilities, Utility Installations

Two 55 gallon drums were found adjacent to the fuel storage area. The drums are not located in a containment. The drums need to be stored in a containment.
