2. Signs and Markers

Mine identification sign is in place at the point of access into the permit area. The sign contains the required information as required by regulation.

3. Topsoil

A trailer with a plow blade attached is parked on the edge of the sediment pond and beginning of the topsoil pile. The trailer need to be removed.

Noncoal waste is stored on the ground the water needs to be picked up and placed into the noncoal storage bins.
